ARTICLES OF INCORPORATION OF

Florida Finisher's Inc.

ARTICLE I - Name

The name of the corporation is: Florida Finisher's Inc.

ARTICLE II - Existence

ARTICLE X - Indemnification

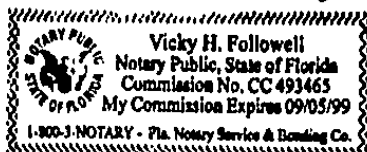
