ARTICLES OF INCORPORATION

OF

TRUEDAT, INC.

The undersigned subscribe to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I

The name of the corporation is "Truedat, Inc." The principal mailing address is: Post Office Box 14749, Tallahassee, Florida 32317-4749. The initial street address of the principal business is 1775 Centerville Road, Tallahassee, Florida 32308.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The corporation is formed for the purpose of engaging in any lawful business permitted pursuant to United States and Florida Law.

ARTICLE IV

The corporation shall have the authority to issue Five Hundred Thousand (500,000) shares of common stock having a par value of \$.001 per share. Initially Michael S. Sims and Eric D. Kilpatrick shall be issued Two Hundred Thousand (200,000) shares each.
