

#### ARTICLE I: NAME

The name of this corporation is Output, Inc. The mailing address of the corporation is 2324 N.E. 18th Avenue, Fort Lauderdale, Florida 33305.

## ARTICLE II: DURATION

This corporation shall have perpetual existence.

### ARTICLE III: PURPOSE
