ARTICLES OF INCORPORATION

ARTICLE I

CORPORATE NAME

The name of this Corporation shall be:

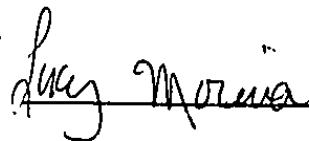

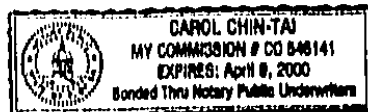

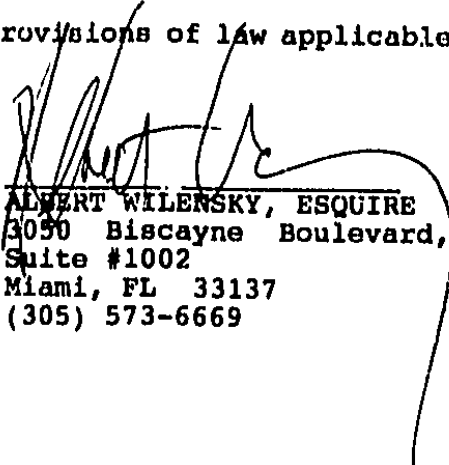
