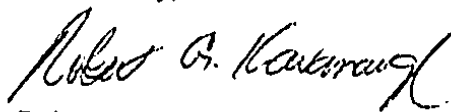

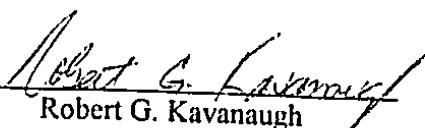

ARTICLES OF INCORPORATION OF
ENGLISH ENTERPRISES, INC.

1. **Name:** The name of the corporation is: English Enterprises, Inc.
2. **Purpose:** The corporation may engage in any legal business.
3. **Stock.** The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of a par value of \$1.00 per share. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer of levy on such shares.
4. **Existence.** The corporation shall have perpetual existence. The corporation shall commence existence upon filing.
5. **Registered Agent.** The initial street address in the State of Florida of the initial registered office of the proposed corporation is 1331 S. Main Street, Gainesville, FL 32601, and the name of its initial registered agent at such address is Robert G. Kavanaugh.
6. **Location.** The location and mailing address of the corporation is 1331 S. Main Street, Gainesville, FL 32601.
7. **Management.** Business of the corporation shall be managed by the stockholders.
