The undersigned, acting as incorporator of **Get Well Pharmacy, Inc.**, under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

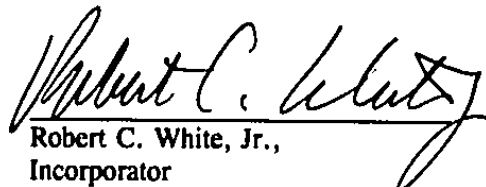

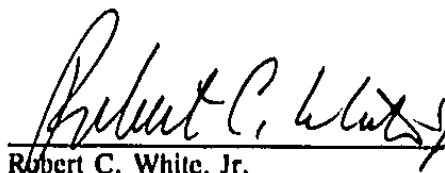
