ARTICLES OF INCORPORATION
OF

ARTICLE I: NAME

The name of this corporation is STEVEN W. KAISER, INC.
and the address of this corporation is 4801 South University
Drive, Suite 204, Fort Lauderdale, Florida 33328.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE

This corporation is organized to transact any lawful
business for which corporations may be incorporated under the
Florida Business Corporation Act and for the purpose of
manufacturing, purchasing or otherwise acquiring, and to own,
mortgage, pledge, sell, assign, transfer or otherwise dispose of,
and to invest in, trade in, deal in and with goods, wares,
merchandise, real and personal property and services of every
class, kind and description; and to carry on any business which
can be advantageously pursued in conjunction with or incidental
to any of the above purposes.

ARTICLE IV: CAPITAL STOCK

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

ARTICLE V: PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI: INITIAL REGISTERED OFFICE AND AGENT

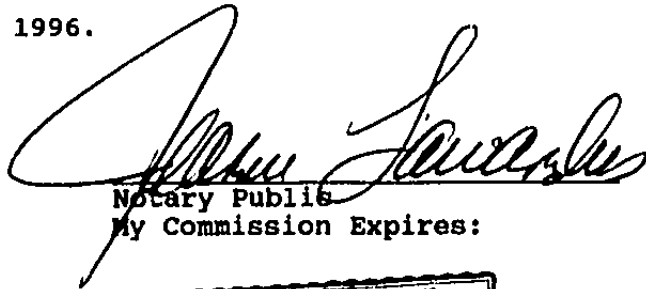

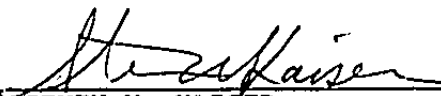
