ARTICLES OF INCORPORATION

OF

ARTICLE I: NAME

The name of this corporation is STEVEN W. KAISER, INC. and the address of this corporation is 4801 South University Drive, Suite 204, Fort Lauderdale, Florida 33328.

ARTICLE II: DURATION
