ARTICLE I

Name of Corporation

The name of this corporation is PIPES & STUFF, INC.

The address of the principal office of this corporation shall be 4080 Budd Road, New Smyrna Beach, FL 32168.

ARTICLE II

Nature of Business

This corporation may engage or transact in any or all lawful activities or businesses regarding retail and wholesale plumbing, supplies, septic systems and other related services permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 50 shares of common stock having no par value per share.

ARTICLE IV

Registered Office and Agent

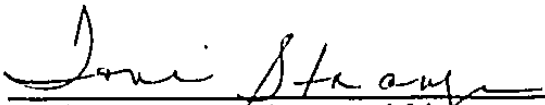
