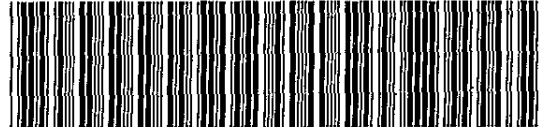

**ARTICLE I** be and it is hereby amended to read as follows:


"The name of this corporation is Macalcer, Inc."
