# ARTICLES OF INCORPORATION OF GIN-CLUD INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of corporation:

# ARTICLE I - NAME AND ADDRESS

The name of the Corporation is: GIN-CLUD INC. The principal office is: 601 N.E. 39th Street, #205, Miami, Florida 33137.

#### ARTICLE II - DURATION

The duration of the Corporation is perpetual.

### ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which Corporations may be Incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To purchase and sell real property and all matters related thereto.
