OF

The undersigned incorporators, for the purpose of forming a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

ARTICLE 1.

The name of the corporation is C D PUBLISHING, INC.

The duration of the corporation is perpetual.
