The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I

#### NAME

The name of the corporation is PETERS HOTEL MANAGEMENT, INC.

#### ARTICLE II

# COMMENCEMENT AND DURATION

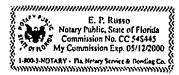
