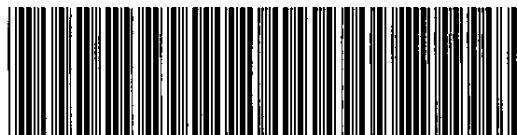

THIRD: The date the dissolution was approved is June 18, 2010 and the effective date of dissolution shall be August 27, 2010.


FOURTH: Dissolution was approved by the shareholders. The number of votes cast for dissolution was sufficient for approval.
