ARTICLE X. AMENDMENT

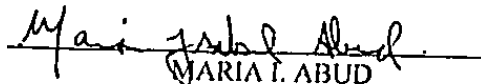

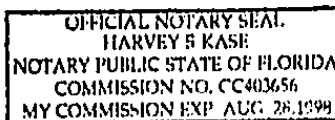

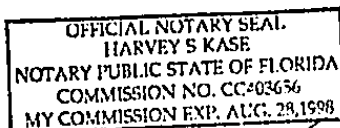
