The undersigned incorporators hereby form a corporation under Chapter 607 of the Florida Statutes.

ARTICLE I. NAME

The name of this corporation shall be: FIN of Carrollwood, Inc. The address of the principal office of this corporation shall be:

<u>ARTICLE II. PURPOSE</u>

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.
