ARTICLES OF INCORPORATION

OF SCHUENEMANN CORPORATION

THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE I

The name of this corporation is: SCHUENEMANN CORPORATION

ARTICLE II

The general nature of the business to be transacted by this corporation is:

- 1. All lawful purposes.
- 2. To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of and to nvest in, trade in, deal in and with goods, wares, merchand trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.
