ARTICLES OF INCORPORATION

Article I

The name of this corporation is A to Z SERVICES, INC..

Article II

The purpose for which this corporation is formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

Article III

Article IV

This corporation is to exist perpetually.

Article V

The number of directors constituting the initial board of directors is one (1), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:
