OF

ARTICLE I - NAME:

The name of this Professional Service Corporation is:
CRAIG S. ROBINSON, C.P.A., P.A., hereinafter referred to as the
"Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the
filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the
practice of Certified Public Accountant, and for the purpose of trans-
acting any or all other lawful business not inconsistent with the Laws
of the State of Florida.

ARTICLE IV - CAPITAL STOCK:


ARTICLE IX - BY-LAWS:
