#### ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of the corporation is HARBOUR LOGISTICS, INC.

# ARTICLE II - PRINCIPAL OFFICE

The principal office of this corporation is located at 704 Via Del Sol, North Fort Myers, Florida 33903 and its mailing address is 704 Via Del Sol, North Fort Myers, Florida 33903.

#### ARTICLE III - PURPOSE
