The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, states as follows:

FIRST: The name of the corporation (hereinafter called the Corporation) is COMPLETE WELLNESS MEDICAL CENTER OF STICKNEY POINT ROAD, SARASOTA, INC.

SECOND: The purposes for which the Corporation is formed are to engage in any business activities or functions which may lawfully be engaged in by a corporation organized under the laws of the State of Florida.

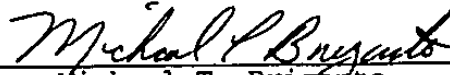
THIRD: The street address and the mailing address of the initial principal office of the Corporation is 1950 Stickney Point Road, Sarasota, Florida 34231.
