The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, states as follows:

FIRST: The name of the corporation (hereinafter called the Corporation) is COMPLETE WELLNESS MEDICAL CENTER OF 4TH STREET, ST. PETERSBURG, INC.

SECOND: The purposes for which the Corporation is formed are to engage in any business activities or functions which may lawfully be engaged in by a corporation organized under the laws of the State of Florida.

THIRD: The street address and the mailing address of the initial principal office of the Corporation is 8730 4th Street North, St. Petersburg, Florida 33702.

FOURTH: The address of the Corporation's initial registered office and the name of its registered agent at that office is CT Corporation System, 1200 South Pine Island Road, Plantation, Florida 33324.

FIFTH: The total number of shares of all classes of stock which the Corporation has authority to issue is five thousand (5,000), all of which shall be common stock with a par value of one cent (\$.01) per share.
