ARTICLE ONE - NAME


ARTICLE ELEVEN - AMENDMENTS

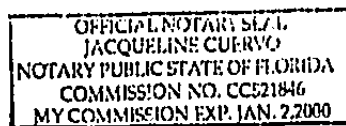
