The undersigned, for the purpose of forming a corporation under the Florida General Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE CORPORATE NAME

The name of this corporation is IMPERIAL NATURAL PRODUCTS & FOOD CENTER, INC.

ARTICLE TWO NATURE OF BUSINESS AND POWERS
