

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I CORPORATE NAME.**

The name of this corporation is American Diversified Services Corporation.

**ARTICLE II PRINCIPAL OFFICE.**

**ARTICLE III EXISTENCE**



## DESIGNATION OF REGISTERED AGENT AND ACCEPTANCE


