The undersigned, for the purpose of forming a corporation for profit pursuant to chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is: Y.G.F., Inc.


ARTICLE IX: RESTRICTIONS OF TRANSFER OF CAPITAL STOCK




