# ARTICLES OF INCORPORATION OF FAMILY LAW CENTER, INC.



# ARTICLE I. CORPORATE NAME.

The name of this Corporation is Family Law Center, Inc.

## ARTICLE II. NATURE OF BUSINESS AND POWERS.

The nature of the business to be transacted by this Corporation is to provide assistance as permitted under the laws of the State of Florida.

## ARTICLE III. CAPITAL STOCK.
