# ARTICLES OF INCORPORATION

# HORSEMAN'S SUPPLY, INC.

The undersigned, being of legal age and natural persons, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of incorporating under the laws of the State of Florida.

# ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be: HORSEMAN'S SUPPLY, INC.

# ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- A. To engage in the retail business of selling farm and livestock feed, supplies and equipment.
- B. To invest the funds of the corporation in real estate, mortgages, stocks, bonds or any other type in investments, and to own real and personal property necessary for the rendering of such professional services.
- c. To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this corporation enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incident to the protection and benefit of this corporation; and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment

or furtherance of such purposes or object of this corporation.

D. It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended.

# ARTICLE III - CAPITAL STOCK

- A. The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of \$1.00 par value common stock.
- B. All or any portion of the capital stock may be issued in payment for real or personal property, services, or any other right or thing having a value, in the judgment of the Board of Directors, at least equivalent to the full value of the stock so to be issued as hereinabove set forth, and when so issued shall become and be fully paid and non-assessable, the same as though paid for in cash; and the Directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock, and their judgment of such value shall be conclusive.
- c. Notwithstanding the foregoing, the corporation shall have the right to increase its capital stock either with or without par value, and to provide in the event of such increase the designations, preferences, voting powers or restrictions, or qualification of voting powers of such additional stock, in an amendment to Articles of Incorporation.

#### ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this corporation shall begin

businoss is \$1,000.00.

# ARTICLE V - TERM OF EXISTENCE

The date when corporate existence shall begin is as of the date of these Articles of Incorporation are filed with Secretary of State of the State of Florida and the corporation shall exist perpetually thereafter unless dissolved by law.

# ARTICLE VI - ADDRESS OF CORPORATION
