ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I - NAME

The name of the Corporation shall be ADVANCED MACHINE TECHNOLOGY OF MANATEE COUNTY, INC. The mailing address of the Corporation shall be, 1263 - 12th Avenue East, Palmetto, Florida 34221.

ARTICLE II - PURPOSE AND POWERS

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.


