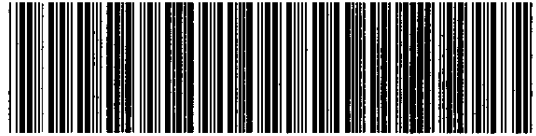

**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
PCC PRINT SHOP, INC.**

In accordance with Sections 607.1003, 607.1006 and 607.1007 of the Florida Business Corporation Act (the "Act"), PCC Print Shop, Inc., a Florida corporation (the "Corporation"), hereby amends and restates in its entirety its Articles of Incorporation as follows:

**ARTICLE I
NAME**

The name of this Corporation shall be PCC Print Shop, Inc.

**ARTICLE II
PURPOSE**

The general purpose for which this Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under the Act.

**ARTICLE III
CAPITAL STOCK**

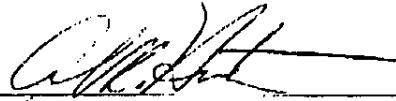
The Corporation is authorized to issue ten million (10,000,000) shares of common stock, each share with a par value of \$1.00. No other class or type of stock will be issued.

**ARTICLE IV
REGISTERED OFFICE AND AGENT**

The street address of the principal office and registered office of the Corporation is 250 Brent Lane, Pensacola, Florida 32503, and the name of the registered agent of the Corporation is Dr. Arlin R. Horton.

Following the recommendation of the Board of Directors, and submission of these Amended and Restated Articles of Incorporation by the Board of Directors to the Corporation's sole shareholder, these Amended and Restated Articles of Incorporation were approved by the Corporation's sole shareholder, with the number of votes cast being sufficient for approval. The date of the adoption of the amendments contained herein is December 31, 2008.
