ARTICLE 1 - NAME

The name of this corporation shall be:

ORLANDO FURNITURE, INC.,

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States or of this state.

ARTICLE III - CAPITAL STOCK
