

On November 1, 2000 we received a notice of Administrative Dissolution of our corporation. We immediately responded with a phone call and this letter is in response to the directions we received. Apparently, according to your records, we never filed our corporation annual report this year. The "important facts" section states that we should have received the annual report to file with the state somewhere between January 1 and May 1 of this year. It also states that we should have received a second notice some time in mid June. Unfortunately we never received either one of these. Our address was officially changed in January 1999. That change of address should have been documented on our 1999 filing. That was either an oversight on my part or it did not get entered into the system at that time. I assume that the report and the second notice was sent to the old address and from there I don't know what happened to it. Our change of address forwarding request at the Post Office is only good for one year so either the documents were returned or the tenants at the old address discarded them. Thankfully, the new tenant walked this notice in to me personally at my place of business yesterday or we would not have even known about the dissolution.

I realize that the filing of the corporation annual report/uniform business report is our responsibility but I have so many reports, taxes, etc., due for our business at so many different times that I rely on the renewal notices and reminders to keep me on schedule. As you can tell by your records we have always filed our reports in the past as we have an active business operating within the guidelines of the state laws. I hope you will take this information into consideration on our behalf.

I have enclosed a check for \$150.00 along with the completed application for reinstatement and our new address. If it is necessary for us to file the report I would ask you to please send the appropriate papers to this address and we will file them with you immediately upon receipt.
