# ARTICLES OF INCORPORATION OF

WALT WATSON CONSTRUCTION, INC.

#### Article I - Name

The name of this corporation is WALT WATSON CONSTRUCTION, INC. and its 'principal office is located at 2718 Appaloosa Rd., Orlando, FL 32822.

#### Article II - Duration
