

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I**

The name of this corporation shall be C.R.V., Inc.

**ARTICLE II**

The corporation shall have perpetual existence, unless sooner dissolved according to law.

**ARTICLE III**

The aggregate number of shares which the corporation is authorized to issue is 1,000, all of which shall be common shares without par value.
