Name

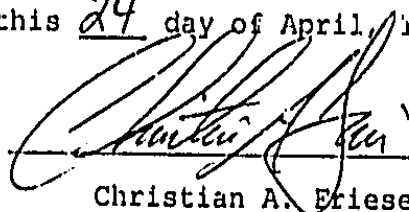

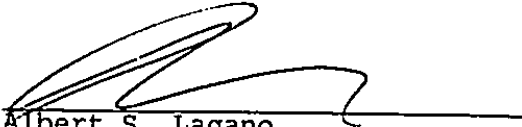
