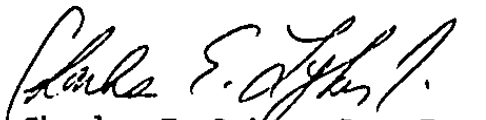

**ARTICLES OF INCORPORATION**

The Applicant, as described below, hereby files Articles of Incorporation of Skorr Media International, Inc. The name of the corporation is "SKORR MEDIA INTERNATIONAL, INC".

**ARTICLE I. DURATION.**

The corporation shall be of perpetual existence.

**ARTICLE II. PURPOSE.**

The corporation is organized and authorized to do any lawful business. In particular the corporation shall act to organize and coordinate business ventures within the State of Florida and other locations in the field of promoting and managing international entertainment and media ventures.

**ARTICLE III. PLACE OF BUSINESS AND MAINTENANCE OF OFFICES.**

The principal place of business of the corporation is at the address of Post Office Box 21091, Tampa, Florida 33622.

Within the State of Florida its registered office will be at 7939 Landmark Circle, Tampa, Florida 33615, and its registered agent will be Orson Skorr at that address. By his signature below, the said Orson Skorr accepts this designation.

**ARTICLE IV. ISSUE AND RESTRICTION ON TRANSFER OF SHARES.**

The corporation shall initially have 10,000 shares of stock with no par value. If a stockholder desires, directly or indirectly, to sell, assign, transfer, pledge as security or in any way dispose of all or a portion of his share or shares of stock, such shareholder (hereinafter called "Selling Shareholder") shall first serve notice (hereinafter called the "Notice of Intended

"Transfer") to that effect upon the Registered Agent of the corporation, stating the number of shares of Stock desired to be sold or otherwise transferred and the specific terms of such transfer and offering to transfer such shares of Stock or interest therein to the other Stockholders in accordance upon the identical terms and conditions as proposed. The other Stockholders shall have the first right to purchase all or any part of the shares of stock, or interest in said stock, so offered by giving notice of acceptance (specifying the number of the shares of stock to which the acceptance is applicable) to the Selling Stockholder within sixty (60) days after receipt by the Registered agent of the said Notice of Intended Transfer.

**ARTICLE V. OFFICERS TO MANAGE CORPORATION WITHOUT DIRECTORS.**

The corporation shall have no directors. The current officers of the corporation are listed below with their addresses:

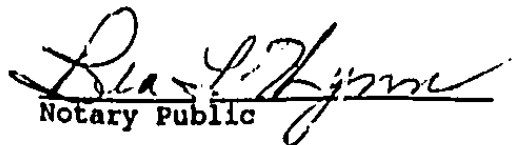

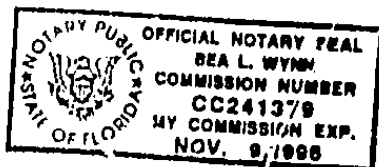
