The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the Corporation is PANTHER PRINTING, INC.

The duration of the Corporation is perpetual.

ARTICLE THREE

The purposes for which the Corporation is organized are:

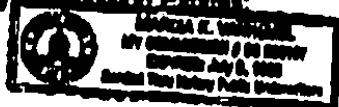
