**ARTICLES OF INCORPORATION
OF
QUALITY MEDICAL & GERIATRIC CARE, INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is QUALITY MEDICAL & GERIATRIC CARE, INC., and the principal address and principal place of business is 6399 - 38th Avenue North, Suite B-6, St. Petersburg, Florida 33710.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o PATEL, MOORE & O'CONNOR, P.A., 18167 U.S. Highway 19 North, Suite 150, in the City of Clearwater, County of Pinellas, Florida 34624. The name of its registered agent at such address is Sandip I. Patel, Esquire.

ARTICLE III - PURPOSE
