ARTICLES OF INCORPORATION OF MULTIPLE CHEMICAL SENSITIVITIES, INC.

A" ACLE I CORPORATE NAME

The name of the corporation is MULTIPLE CHEMICAL SENSITIVITIES, INC

ARTICLE_II DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III PURPOSE
