THE UNDERSIGNED, KALMUN LEE hereby executes this document for the pulposes of becoming incorporated under the laws of the State of Florida, and forming a corporation under the following proposed Certificate of Incorporation:

ARTICLE_I

The name of this Corporation is LIBERTY REALTY, INC.

ARTICLE II

The general nature of the business to be transacted by the Corporation is as follows:
