

ARTICIES OF INCORPORATION OF ADA SOFTWARE DEVELOPERS INC.

56 HZ 29 H

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE CHE: NAME: The name of the comporation shall be ADA SOFTWARE DEVELOPERS INC.

ARTICLE TWO: DURATION: The term of existence of the corporation is perpetual.

ARTICLE TIREE: PURPOSE: The purpose of the corporation is to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
