ARTICLE I - NAME

The name of this Corporation is FOUR B Z, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on July 24, 1996.

ARTICLE III - PURPOSE

The purpose for which the Corporation is organized is to own and rent airplanes and to do all other things allowable by law.

ARTICLE IV - PRINCIPAL OFFICE


ARTICLE IX - INDEMNIFICATION


