

1. The name of the corporation is:

2. The principal place of business and mailing address of the corporation is:


4. The Registered Agent of the corporation is Richard T. Hughes, and the registered address is 1518-B Florida Blvd, Bradenton, Florida 34207.

The number of directors may be raised or lowered by amendment of the by-laws of the corporation, but in no case shall be less than one.


