Certificate of Incorporation

of

Southeast Construction & Trucking Inc.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit pursuant to the following Articles of Incorporation.

Article I: Name

The name of the corporation shall be Southeast Construction & Trucking Inc.

Article II: Principal Place of Business

The principal place of business of said corporation shall be in Tallahassee, Leon County, Florida, with the privileges of having branch offices at other places within the State of Florida and within or without the United States of America. The mailing address of said corporation is 4727 North Monroe Street, Tallahassee, Florida 32303.

Article III: General Nature of Business

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all things hereinafter mentioned as freely and to the same extent as natural persons might or could do; viz:

- (a) To perform the following services: construction, hauling, and associated activities.
- (b) To borrow money for its corporate purposes; to make, accept, endorse, execute and issue promissory notes, bills of exchange, bonds, debentures, or other obligations for any purpose in or about the business of the company; and, if deemed proper, to secure the payment of any such obligation by mortgage, pledge, deed of trust, or otherwise.

- To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes, or the attainment of any of the objects or the furtherance of any of the powers hereinafter set forth, either alone or in association with other corporations, firms or individuals, and to do every other act and thing incident or appurtenant to, or growing out of, or connected with the aforesaid business or powers, or any part thereof, provided the same be not inconsistent with the laws under which this corporation is organized.
- (d) Generally, to make and perform contracts of any kind and description, and, for the purpose of attaining any other act or thing, and to exercise any and all powers which a corporation or natural persons could do or exercise; and do and perform any and all things necessary or incident to the performing and carrying out of the powers hereinabove specifically delegated or implied.

Article IV: Amount of Capital to Begin Business

The amount of capital with which this corporation shall commence business shall be One Thousand and no/100 Dollars (\$1,000.00).

Article V: Perpetual Existence

This corporation shall have perpetual existence unless sooner dissolved by law.

Article VI: Capital Stock

The amount of the capital stock of this corporation shall be one hundred (100) shares of common stock of the par value of Ten Dollars (\$10.00) per share, payable in cash, property, labor or services at a just valuation to be fixed by the Board of Directors at a meeting to be called for that purpose.

Article VII: Number of Directors

The number of directors of this corporation shall not be less than two (2).
