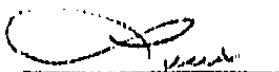
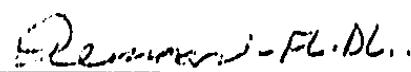
The undersigned, a citizen and resident of the State of Florida, in order to form a corporation pursuant to the laws of the State of Florida, does hereby certify:

1. The name of the corporation is "American Legal Associates, Inc."
2. The general nature of the business to be conducted by the Corporation is the transaction of any and all lawful business.
3. The Corporation will have perpetual existence.
4. The corporation is authorized to issue two hundred (200) shares of common stock, all of which will be without par value.

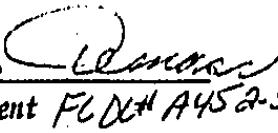

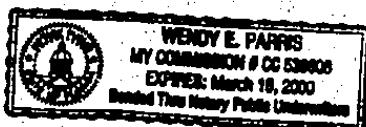
