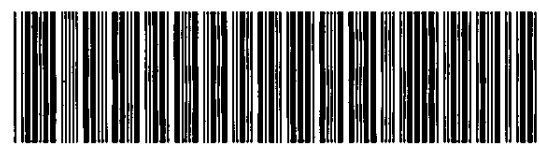

Pursuant to the provisions of Section 607.1006, Florida Statutes, **LOGGERS' INSURANCE, INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **LOGGERS' INSURANCE, INC.**
2. Article 1, Section 1.1 of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"Section 1.1. Name: The name of this Corporation is
BELFORT BROKERS, INC."
