ARTICLE I - NAME

The name of this corporation is The Bay Club, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value common stock which shall be designated as "Common Shares".
