ARTICLES OF INCORPORATION 95 JUL 31 AM 10: 18 OF FLORIDA SECURITY LOCKERS, INC. LANGUE FLORIDA

ARTICLE I - NAME

The name of this Corporation is Florida Security Lockers, Inc.

ARTICLE II - NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The authorized capitol of the Corporation shall be 10,000 shares of the common stock at a par value of \$1.00 per share.

ARTICLE IV -TERM OF EXISTENCE

This Corporation is to exist perpetually.
