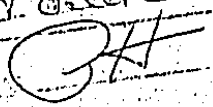
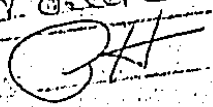

**ARTICLES OF INCORPORATION OF
PATRICK D. BESTE AND LINDA K. BESTE
PROFESSIONAL ASSOCIATION**

We the undersigned, hereby associate ourselves together for the purpose of becoming a Professional Association for profit under the Florida Business Corporation Act and the Florida Professional Services Corporation Act pursuant to the following Articles of Incorporation.

ARTICLE I. Name

The name of the Professional Association shall be Patrick D. Beste and Linda K. Beste, Professional Association.

ARTICLE II. Principal Office

The principle place of business and mailing address of this Professional Association shall be 11405 175th Road North, Jupiter, Florida 33478.

ARTICLE III. Capital Stock

The number of shares of stock that this corporation is authorized to have outstanding at any one time is limited to Two Hundred (200) shares, without par value. Such shares shall be of a single class.

ARTICLE IV. Duration

The Professional Association shall have perpetual duration.

ARTICLE V. Incorporator

The name and address of the incorporator to these Articles of Incorporation is ROBERT S. COHEN, The 110 Tower, Suite 1710, 110 Southeast Sixth Street, Fort Lauderdale, Florida 33301.

ARTICLE VI. Initial Directors

The names and addresses of the initial directors are PATRICK D. BESTE and LINDA K. BESTE, at the principal place of business, 11405 175th Road North, Jupiter, Florida 33478

ARTICLE VII. Purposes of Corporation

The general nature of the business to be transacted by the Professional Association shall be and is to engage in every aspect of the discipline commonly known as Speech Therapy, including without limitation, promotion of communication through education, research, consultation, and therapy as well as being consultants and educators to organizations, businesses, etc. The professional services involved in the Professional Association's practice of speech therapy may be rendered only through its officers, agents, and employees who are duly authorized and licensed.

The Professional Association shall not engage in any business other than the practice of speech therapy as described above. However, this Professional Association may invest its funds in real estate, mortgages, stocks, bonds, and other types of investments; and may own real estate and personal property necessary for the rendering of the professional services authorized hereby.

ARTICLE VIII. Amendments Hereto

The Professional Association reserves the right to amend, alter, change, or repeal any provision contained herein. The proposal submitted by the stockholders must be subsequently approved at a stockholder's meeting by fifty-one per cent (51%) of the stock entitled to vote. This amending process, however, may be suspended and amendments made upon written approval by all of the stockholders.
