ARTICLES OF INCORPORATION FOR

MALE POTENCY CORPORATION OF JACKSONVILL

SE JULS I ANIIS I The undersigned, acting as Incorporators of a corporation under the Florida Busines Corporation Act, adopt the following Articles of Incorporation for such corporation:

- Name. The name of this corporation is MALE POTENCY CORPORATION OF 1. **IACKSONVILLE**
- 2. Duration. The period of its duration is perpetual.
- Purpose. The purpose is to engage in any activities or business permitted under the 3. laws of the United States and State of Florida.
- Capital Stock. The corporation is authorized to issue ten million (10,000,000) shares, all 4. of voting Common Stock having a par value of one cent(\$0.01) per share.
- 5. Initial Registered Office and Agent and the Principle Office. The name and address of the initial registered agent and office and the principle office of this corporation is as follows:

б. Initial Board of Directors. This corporation shall have one director initially. - 8. Amendment of Articles. This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
- 9. Indemnification of Directors and Officers and Employees. This corporation shall to the fullest extent permitted by Florida Statute Section 607,0850, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said section from and against any and all of the expenses, liabilities or other matters referred to in or covered by said section, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, agreement, vote of stockholders or disinterested directors or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of such a person.
- 10. Amendment of Articles. The power to adopt, alter, amend or repeal the Articles of Incorporation of this corporation shall be vested in the Shareholders by a sixty-seven percent (67%) vote.
